

# DRR BRINGIN' THE HEAT BBQ CONTEST

## OFFICIAL RULES

1. **CONTESTANT-** any individual or team that will prepare and cook and entry or entries for the purpose of being judged. Contestant will be referred to as "Griller." Members of the D'arbonne Range Riders BBQ Committee may not compete in the competition.
2. **EQUIPMENT-** Each Griller will supply all equipment necessary for the preparation and cooking of their entry. Grillers may cook on any type of grill /cooker (no open fire pits). The health and safety of contestants and event goers should be a primary consideration when selecting appropriate cooking fuels. **NO ELECTRICITY OR WATER WILL BE PROVIDED.**
3. **MEAT PICKUP/PREPARATION/COOKING-** Meat will be provided by Darbonne Range Riders. Grillers can pick up meat at the DRR Clubhouse at 202 Rodeo Road beginning Friday May 17<sup>th</sup>, 2024, at 9:00am. **ALL MEAT MUST BE COOKED ON-SITE. Cooking may not begin prior to 6:00 am on Saturday May 18th.**
4. **CLEANLINESS AND SANITATION-** each griller is required to keep all equipment contained within their space. Grillers are expected to maintain their cook sites in an orderly and clean manner and to use good sanitary practices during prep, cooking, and judging. Grillers are responsible for the cleanup of their site once the competition has ended.
5. **CATEGORIES-** the following are the categories that will be judged:
  - a. **Boston Butt**
  - b. **Brisket**
  - c. **Spare rib**
6. **JUDGING-** entries will be submitted in the containers provided by DRR. Meat may be sauced or un-sauced. Grillers are to provide samples large enough for all judges. Entries must be turned in ready for judging by 5:00pm
7. **WINNERS-** winners will be announced on the arena floor during the rodeo.
8. **PAYOUT-** 100% added money will be paid out to each category. 50% of entries will be paid out to each category.
9. **REFUND OF ENTRIES-** There will be NO refund of entries.
10. **INTERPRETATION OF RULES-** the interpretation of the rules are those of the DRR BBQ Committee and their decision is **FINAL**.
11. **DISQUALIFICATION-** a griller can only be disqualified by the DRR BBQ committee for and of the following reasons:
  - a. There is anything foreign other than meat/sauce in judging tray.
  - b. Entry is turned in after 5:00 pm.
  - c. Not cooking the meat that was provided.
  - d. Griller is found to be in violation of any rule listed above.
